Kannan along with K9 Gusto has been performing demining/searching duty, at around 0815 hrs, an IED has been found near a culvert ahead of S Kawtlian village alongside NH 02 at GR-24degree25'13.8"N 93degree42'55.7"E . It seems to be a remote controlled IED prepared with power Gel/Gelatin sticks (approx weight 3 Kgs) as it don't have any command wire. The same has been informed to all concerned.

After taking due precautions and and safety measures, it has been demolished by BDDS in situ at about 1010 hrs.

It is to inform you that today i.e. on 31/03/2025 at around 0815 hrs, BDDS (Bomb Detection and Disposal Squad) of 58 Bn has detected an IED near a culvert on the roadside just ahead of S Kwatlian Village towards CC Pur. BDDS under command ASI/GD S. Kannan along with K9 Gusto has been performing demining/ searching duty from Kangvai Junction to CC Pur on NH-2 w.e.f. 0715 hrs. During the demining duty, at around 0815 hrs, an IED has been found near a culvert ahead of S Kwatlian village alongside NH.02 at GR-24°25'13.8"N 93°42'55.7"E. It seems to be a remote controlled IED prepared with Power Gel/ Gelatin sticks (approx. weight 3 KGs) as it don't have any command wire. The same has been informed to all concerned.

2. After taking due precautions and safety measures, it has been demolished by BDDS in situ at about 1010 hrs.
