1. This is to bring to your notice that a joint operation was conducted by personnel of Assam Rifles and Churachandpur Police, during which a Mobile Vehicle Post(MVCP) of Assam Rifle under Nb Sub Vinod Singh was established at Nghathal Village, Churachandpur near Lanva Bridge (approximately 04 km South-East of HQ Veng) on 06 Apr 2025 wef 1345 hrs.
2. On 06 Apr 2025, at approximately 1430 hrs, a suspicious individual was noticed loitering near a house alongwith his wife Mrs. Liandouniang. On being apprehended and questioned, the individual was identified as a Myanmar national, namely: Name: Mr. Dongkhenmang, Male, Age: 39 Years, Address: Tonzang, Myanmar.
3. Upon detailed checking, approximately 04 grams of suspected Brown Sugar (Likely for personal consumption) was recovered from his possession. Further inquiry revealed that the individual had entered India on a Single Entry Border Pass issued by Assam Rifles on 28 Feb 2025, with validity up to 07 Mar 2025. However, the individual had continued to reside illegally in Churachandpur even after the expiry of his pass, in clear violation of applicable laws.
4. The timely coordination and effective synergy between Assam Rifles and Churachandpur Police led to the Immediate verification and initiation of further investigation at the spot by the Police team present during the operation.

5. In view of the above, it is requested that an FIR to be registered under the relevant legal provisions for the following offences and do the needful:

- (a) Illegal stay by a foreign national (Myanmar)
- (b) Individual moving beyond 10 Km of Indo-Myanmar Border.
- (c) possession of Contraband (Suspected Brown Sugar)
