Subject: - Report.

Sir,

I have the honour to state that today i.e. 04/03/2025 at about 12:25 pm a reliable information was received regarding the presence of some miscreants in and around Khabam Lamkhai area of Imphal East District with a view to extort money from transport vehicles. Acting on the information, a team of CDO-IW led by Inspector Kh. Pathou Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Control Room and conducted cordon and search operation at Khabam Lamkhai. During that two unknown persons were seen walking at Khabam Lamkhai near Coffee Culture shop in a very suspicious manner and hence, they were detained at the spot for checking and verification.

On spot verification, they identified themselves as (i) Pebam Rojit Singh (35 yrs.) @ Dipu S/o. P. Khomei Singh of Napet Palli Maning Leikai, Imphal East District and (ii) Leitanthem Ajah Singh (25 yrs.) S/o. (L) L. Ranjan Singh of Sekta Awang Leikai, Imphal East District.

On spot checking:

- (1) The following articles were recovered from the possession of Pebam Rojit Singh:
 - i) One iPhone 14 Pro Max mobile handset along with one Jio SIM card bearing mobile no. 8837457930 (as disclosed by him).
 - ii) One Redmi 10 Prime mobile handset along with two Airtel SIM cards bearing mobile nos. 8414800856 and 8732077564 (as disclosed by him).
 - iii) One black wallet containing a sum of Rs. 300/- (rupees three hundred only) and one Aadhaar card.
 - iv) One dairy of GOLDEN TOBACCO MFG. CO. (P). LTD.
- (2) The following articles were recovered from the possession of Leitanthem Ajah Singh:
 - (i) One Redmi Note 9 Pro mobile handset along with one Airtel SIM card bearing mobile no. 7627900383 (as disclosed by him).
 - (ii) One moto g power (2021) mobile handset along with one Airtel SIM card bearing mobile no. 9774425865 (as disclosed by him).
 - (iii) One iPhone 15 mobile handset along with one Airtel SIM card bearing mobile no. 7629949549 (as disclosed by him).
 - (iv) One Aadhaar card.
 - (v) One brown wallet

Due to the sensitiveness of the area, there was an inconvenience in conducting proper verification at the spot and hence, the detainees along with the recovered articles were brought at CDO-IW office Complex, Minuthong for proper verification. During preliminary verification they disclosed that they are presently working as middlemen and collects money from transport vehicles for UNLF organisation.



Hence, Pebam Rojit Singh and Leitanthem Ajah Singh were arrested at CDO-IW office Complex, Minuthong at 05:10 pm and 05:15 pm and the above recovered articles were seized at CDO-IW office Complex, Minuthong at 05:20 pm and 05:25 pm respectively by observing formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
