Respected Madam,

I am writing my concern regarding the disturbing incident which took place at our bathroom area today in between 9.20 am to 9.28 am. It is deeply troubling to witness a phone peeping on me from the upper hollow part of our bathroom making videos of me while I was in the privacy of my bathroom. However, I do suspect a man from our neighbourhood, namely Tomba @ Moses Karong, whom Bebi (a neighbour) saw him in front of our house around 9.20 am this morning.

Even before this incident, this suspected man passes me regular disturbing acts and comments on me which amounts to outraging my modesty as a woman.

This gross violation of my privacy has caused me significant distress and I am deeply concerned about the impact it may have on my personal well being and safety. The possibility of circulating my nude video while bathing is also very high.

I request that immediate action be taken to investigate this incident against the accused person and further take legal actions against those responsible for this violation.
