Elangbam Surjit Singh, CDO Unit Kakching lodged a written complaint report to OC/WKG-PS stating that on the same at around 1430 hrs received an input from Major Shivam Sachan, Company commander COB, Waikhong 46 AR, that some members of a banned outfit organization KCP were present in Langmeidong area, to serve their demand letters to some business men and Saw Mills in Kakching District. On receiving the input, I along with my team immediately rushed to Langmeidong Kakyai area, Indo Burma Sugnu road and conducted frisking and checking by establishing a mobile check point. As per the input received, during the frisking and checking, our team noticed one Maruti Baleno (Magma Grey in colour) without registration number was seen coming from Waikhong side proceeding towards Langmeidong. The said vehicle was detained for verification. As there was a need for further verification, the two individuals along with the vehicle were taken to CDO office, Kakching.

On Questioning the driver identified himself as Mayanglambam Sanathoi Singh 30yrs S/o. M. Achou Singh of Kakching Khunou Chekshapat School Maning Leikai, Kakching District, and the occupant identified himself as Sanasam Suraj Singh 27yrs S/o. S. Somajit Singh of Wangoo Parking, Bishnupur District. Further, they disclosed that they were members of the banned organization Kangleipak communist party, (Taibanganba) and had come to Tonsen area, Sugnu for monetary extortion. They were tasked to serve extortion demands at Sugnu area and were returning after serving an extortion to a plywood factory located at Tonsen.

On questioning, Mayanglambam Sanathoi Singh 30yrs disclosed that he joined the banned organization in November 2024 through one Thouna@Naocha of Kakching Khunou Thingnam Leikai of the said organization and worked under the command of L. Rajesh @Malemnganba of Langmeidong Mamang Leikai S/S Vice Chairman of the said banned organisation. On his production, recovered one Redmi 13C 5G bearing IMEI1-866657070299649 & IMEI2-866657070299656.

Further on questioning Sanasam Suraj Singh 27yrs, he disclosed that he joined the banned organization in August 2024 through one Kiyam. Rajesh of Wangoo Parking and was working under the command of L. Rajesh @ Malemnganba of Langmeidong Mamang Leikai S/S Vice-chairman of the said banned organization. On his production recovered one Samsung Galaxy A35-5G bearing IMEI1-350722243206245/01 & IMEI2-350722243206244/01.

They admitted that they are directly involved in carrying out extortion activities in Kakching area, Kakching Khunou area, Hiyanglam area, Waikhong area and Sekmaijin area for the banned organization i.e. KCP (Taibanganba).

Accordingly the two individuals have been arrested one after another at 1530 hrs & 1535 hrs by observing formalities. The items mentioned above along with the Baleno (Maruti) car have been formally seized at around 1540 by observing formalities. The relevant videography of the seizure and arrest was done at CDO Office, Kakching. The arrested persons along with the copies of arrest memos and the seized articles are handed over to you for taking further necessary legal action against them. Hence the case.
