

12. First Information contents: On 25/01/2025 at about 8:10 am one complainant namely K. Nepolian Singh, CDO Unit/KCG lodged a written report to OC/WKG-PS stating that on 25/01/2025 at about 4.00 am, on receipt of a reliable input from 46 Assam Rifles regarding likely presence of war like stores at Thongjao Mamang Ching areas, a combined team comprising of CDO Unit Kakching, one coloumn of 46 AR led by Maj. Shivam Sachan, a platoon of 151-F coy Bn. BSF led by Insp. Hardev Singh and a team of Waikhong PS led by ASI N. Gopen Singh under the command of Subedar Soraisham Birla Singh, OC CDO KCG, under the supervision of Binoy Chongtham, MPS, Addl. SP(Ops), Kakching and the overall supervision of Thokchom Vikramjit Singh, IPS, Superintendent of Police, Kakching conducted search operation at the suspected areas from 06.00 a.m. to 7.30 a.m. During the search operation the area was condoned off and search was conducted at suspected areas. On searching at a secluded area near bushes, the following items suspected to be concealed by unknown miscreants were found containing in a plastic bag (bora) white in colour. While opening the said plastic bag (bora) found the following items:


