12. First Information contents: Today i.e. 01/02/2025 at 1130 hrs. the complt. HC O. Jogeshchandra Singh, CDO Kakching lodged a written complaint report to OC/WKG-PS stating that on the same day based on an intel about presence of unknown miscreants mainly extortionist provided by Maj Shivam Sachan, Coy Cdr,C-Coy,46 AR a cordon and search operation was conducted at Langmeidong Mamang Awang leikai area from 0600 hrs by a combined team of CDO Unit Kakching, team of WKG-PS and a Platoon of F-Coy, 151 Bn. BSF led by Inspt. Hardev Singh. During the search, the area was cordoned off and search was conducted along with verification of the residents. During the operation, while conducting verification, some suspected individuals matching with the intel provided, were detained. On basic questioning, one individual was found restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, Kakching for further examination and verification as there was apprehension of mob formation in the meantime by local people especially women. On examination, the detainee identified himself as one Leisangthem Rajesh Singh (30) @ Malemnganba S/o (L) Leishangthem Kullabidhu Singh of Langmeidong Mamang Awang Leikai was found to be an active cadre of banned organization KCP(Taibanganba). He admitted that he was currently serving as Vice Chairman of the above mentioned banned organization. During questioning, he further admitted that he was in charge of extortion activities in Kakching, Thoubal and Imphal area. As a Vice Chairman of the banned organization, he was also tasked to recruit new cadres to work for the banned organization. He joined the banned organization UNLF in 2000 and later joined KCP(Taibanganba) in 2009. He further admitted to serving extortion demands and collecting extortion money from Local businessman, individuals and Govt. Officials. He is also involved in kidnapping for extortion demands.

Following the admissions, the said individual was arrested from the office of the CDO-Unit Kakching at 0845 hrs. From his possession, the following items were formally seized at the office of CDO Unit, Kakching at 0900 hrs and videography of the same was done.
