First Information contents: today i.e 14/03/2025 at around 1130 hrs, received a reliable information regarding presence of cadre of banned organization RPF/PLA at Langmeidong Mamang Leikai area who is suspected to be involved in the incident of issuing threat to the staffs of H. Keinahal Memorial English School, Langmeidong. On receipt of the information, the team immediately rushed to the area and conducted search at suspected locations. During the search, one suspected individual was detained at Langmeidong Mamang Leikai. On preliminary verification, the individual was identified as one Thokchom Diamond Meitei @ Tamthouba (26)s/o Thokchom Britain Meitei of Serou Bazar Awang Leikai, Kakching District. On further questioning, he further disclosed that he was an active cadre of the banned organization RPF/PLA. He joined the banned organization in the year 2021 and was later arrested in the year 2022. He rejoined the banned organization again in the year 2024 as a result of the ethnic conflict in the state. He also revealed that on 07th March, 2025, as instructed by one s/s 2nd Lt Manikanta of the banned organization RPF/PLA, he had gone to H Keinahal Memorial English School and served extortion demands to the school administration. On body search, recovered the following items


