First Information contents: Today i.e, 16/03/2025 at 05:20 PM received an information that on the same day at about 04:40 PM one unknown Bajaj Pulsar 180 red in colour bearing registration MN04B 3161 driven by unknown rider, which was coming from Waikhong side proceeding towards Langmeidong side and one Yamaha R15 red in colour bearing registration No. MN01A Q5292, which was coming from Langmeidong side towards Waikhong side collided each other at Elangkhanpokpi along the Indo Burma Sugnu Road due to rash and negligent driving on the part of both riders.. As a result of which the rider and two occupants of the Bajaj Pulsar 180 and Yamaha R15 received injury on their persons and evacuated to Hospital for medical treatment. Later the unknown bike rider of the Yamaha R15 succumbed to his injury at the Jivan Hospital, Kakching.


