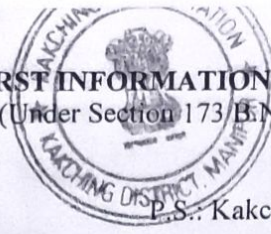

Sir,

It is to report that today i.e. 03/02/2025, based on reliable input regarding presence of miscreants involved in extortion activities, a cordon and search operation was conducted at Irengband Hawairou area from 0400 hrs by a combined team of CDO Unit Kakching. During the search, the area was cordoned off and search was conducted. During the operation, one suspected individual matching with the input provided was detained along with one Maruti Suzuki A-Star Bearing No. MN04P-2528 (Bright Red in colour) from Irengband Hawairou Lai Maya. During preliminary questioning, the individual was restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, Kakching for further examination and verification at spot was not possible as there was security apprehension for the search team. On examination, the individual identified as Pheiroijam Thoiba Singh (23) @ Chalamba S/O. Ph. Manglem Singh @ Lairenpa of Irengband Hawairou Lai Maya, Kakching District. He admitted that he is an active member of UPPK (United People's Party of Kangleipak) the banned organization. During questioning, he further admitted that he was involved in extortion activities in Kakching, Thoubal and Imphal area for the said banned organization. He joined the banned organization UPPK in May, 2024 through one Prem and works under the command of Cheina S/S Finance Secretary of said organization.

Following the admissions, the said individual was arrested from the office of the CDO-Unit Kakching at 0510 hrs. From his possession, the following items were formally seized at the office of CDO Unit, Kakching at 0520 hrs and videography of the same was done.

1. One VIVO Mobile Phone IMEI 1-869308048780693 and IMEI2-869308048780685
2. One Maruti Suzuki A Star VXi, bearing Registration No.MN04P-2528 (Bright red in colour)
3. One wallet (Brown in colour) with logo "PUMA" with the following items
 - (i) One AADHAR card with no. 3435 1801 7490
 - (ii) PAN card bearing no SIKPS9112R
 - (ii) Voter ID card with no KMY0412197

The arrested individual along with the seized items are handed over to you for taking further necessary action.




