

Sir,

It is to report that today i.e. 12/02/2025, at around 1100 hrs, received a reliable information regarding presence of unknown miscreants at Kakching Irum Mapal area who are involved in extortion activities. Accordingly a mobile checked point was established at Kakching Irum Mapal area and conducted frisking. During the frisking and checking at around 1240 hrs, one i20 Asta car bearing Registration No.MN03P-7854 (silver in colour) was coming from Kakching side toward Kakching Lamkhai side matching with the Intel provided was detained. On basic questioning, the individual was found restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, Kakching for further examination and verification at spot was not possible as there was security apprehension for the frisking team. On examination, the detainee identified as one Moirangthem Gobin Meitei @ khaba 38yrs S/o. M. Ibotombi of Langathel Inkholnung Leikai, Thoubal was found to be an active cadre of banned organization KCP (City Meitei). He admitted that he was currently serving as second Lieutenant of the above mentioned banned organization. During questioning, he further admitted that he was in charge of extortion activities in Kakching, District area. As a second Lieutenant of the banned organization, he was also tasked to recruit new cadres to work for the banned organization and also involved in kidnapping for extortion demands, the same videos was shown in his Mobile Phone that's One plus NORD CE4. He further stated that he joined the banned organization KYKL in 2007 under army No. 772 and got 75 days basic training at Tannan, Myanmar and surrender in 2017 and later joined KCP (City Meitei) in 2023.
