On receiving the information, the teams of CDO Unit Kakching and a column of 46th AR C-Coy led by Major Shivam Sachan rushed to the said area and conducted frisking and checking at Aihang village near waiting shed by establishing a mobile check point. During the course of checking one unknown youth matching with input was seen coming by foot from Waikhong towards Aihang village in a very suspicious manner.

Due to his suspicious nature the said individual was detained for verification. On basic questioning, the individual was found restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, at around 1330 hrs. Kakching for further examination and verification as conducting the same at the spot was not possible as there was security apprehension for the frisking teams. On examination, the detainee identified as Moirangthem Roshan Singh (40) yrs. S/o. M. Nando Singh of Chairel Awang Leikai, Kakching District. During questioning, he disclosed that he is a member of the banned organization PREPAK-PRO and has been working under the command of one S/S commander Amom Indrajit Singh @ Wakheiba of the said organization. He joined the banned organization in April 2024 through the above mentioned Amom Indrajit Singh @ Wakheiba. He admitted that he is directly involved in carrying out extortion activities in various institutes in and around Wangoo Chairel, and Pangaltabi areas namely (i) Saraswati Bal Vidya School, Pangaltabi (ii) Modern Pangaltabi High School, Pangaltabi (iii) Borni Memorial English School, Pangaltabi & (iv) Elite Academy Chairel) for the said banned organization. On his production recovered one Mobile LAVA Blaze bearing IMEI 1-355295781180671/78 & IMEI 2-355295781180689/78 and the same was seized at 1505 hrs. by observing formalities. Thus, from the above facts and circumstances, he was arrested at CDO office, Kakching at 1525 hrs. by observing formalities. Videography of the seizure and other documentation were done at CDO office, Kakching, due to law and order situation and there were lots of vehicles plying on the highway passing the spot.
