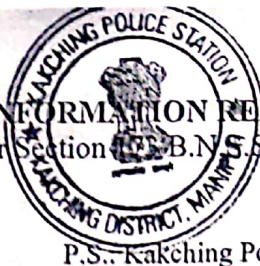

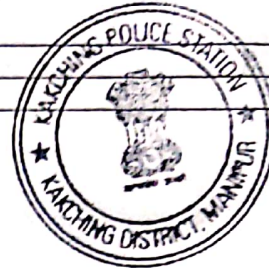

YKP4A65718 & Chassis No. MA1UJ4YK2P2A13136 registered in the name of my wife namely Smt. Leichombam Jeena Devi towards Imphal, on the way in between Kakching Lamkhai and Sora Village, I was stopped by some unknown masked persons who were there in one black colour Bolero and a white car. Then, I was asked to come down from the vehicle on gun point and they took the vehicle from the scene. They also threatened me that if I ever report the matter to the police, they will kill all my family members. They left me alone there and later I came back home by a Tata Magic. Their language tune like of tribal and Muslims.

It is therefore, requested kindly to recover the said Mahindra Thar and take up necessary legal action against the unknown culprits as per law.
