I have the honour to state that today i.e. 26/12/2024 at about 5:40 pm when I along with a police personnel of KCG-PS namely Asem Khamba Singh bearing C/No.0908773 went to served Police Summon U/S 179 BNSS to one individual namely Naorem Priyobarta Singh (36) yrs S/o N. Purnima Singh of Kakching Wairi Sabal Leikai to appear before me for examination in c/w FIR NO. 80(11)2024 KCG-PS, many womenfolk and some local male persons including the family members of the summonee ignored receiving the summon to be served to Naorem Priyobarta Singh and started gathering many people by ringing electric pole and alarming. Upon seeing the public gathering at the area and their attitude I let Asem Khamba Singh bearing C/No.0908773 left the place immediately and I boarded to the Gypsy of the CDO team. Thereafter, the womenfolk and some local male persons including the family members organised a mob by belling electric post numbering about 200 to 300 and wrongfully confined me and CDO-KCG team (Kilo- 77) who was accompanying me to cause arrest Naorem Priyobarta Singh (if available at the moment) by blocking the road from the both sides for about 2 (two) and ½ (half) hours in front of the house of Naorem Priyobarta Singh (36) yrs S/o N. Purnima Singh of Kakching Wairi Sabal Leikai, PO & PS- Kakching, Kakching District. In the meanwhile OC/KCG-PS entered at the place where we were confined. In that the mob charges many allegations regarding police activity to Mr. Naorem Priyobarta Singh and others accused residing in Kakching area to OC/KCG-PS and then OC/KCG-PS make known about the legal proceedings of the incident occurring at the moment and police activity. After about 1(one) hours, I along with the CDO-KCG team were rescued from the mob by a Police team including CDO KCG team.

It is, therefore, requested to kindly take up necessary legal action to punish the culprits according to the law of the land.


