I have the honour to report that today i.e. 28/03/2025 at around 1600 hrs. received a reliable information about the presence of some member of banned outfit UG organization KCP (City Meitei) at Wangoo areas. On receiving the information, CDO teams rushed to the said area and conducted frisking and checking at Wangoo Tera Mameiching by establishing a mobile check point. During the course of checking one unknown youth was seen coming by foot from Wangoo toward Wangoo Lamkhai in a very suspicious manner towards the check point.

Due to his suspicious nature the said individual was detained for verification. On basic questioning, the individual was found restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, Kakching for further examination and verification at spot was not possible as there was security apprehension for the frisking teams and due to darkness of spot. On examination, the detainee identified as Sharungbam Thoiba Singh (43) yrs. S/o. S. Shamu Singh of Wangoo Tera Mameiching, Kakching District. During questioning, he disclosed that he is an active member of the banned organization KCP(City Meitei) and was working under the command of one S/SSgt Major Bobo @ Arnold of the said organization. He joined the banned organization in July 2024 through the above mentioned Bobo @ Arnold. He **admitted that he is directly involved for carrying out extortion activities in Uchiwa and Pangaltabi areas** for the said banned organization. On his production recovered one Mobile Redmi 8A bearing IMEI 1-864334050055563 & IMEI 2-864334050055571 and the same was seized at 1840 hrs. by observing formalities. Thus, from the above facts and circumstances, he was arrested at CDO office, Kakching at 1855 hrs. by observing formalities. Videographer of the seizure and other documentation were done at CDO office, kakching.

The arrested person along with the seized article are handed over to you for taking further necessary legal action.




