Today i.e. 6th February 2025 at 11.35 am received an information from social media facebook, that the band outfit organization K.C.P. MC Progressive uploaded a warning post against BJP State Government and Manipur Police by saying that "Imphal East District ki Porompat Police Station na Singjamei gi mafam amadagi tha ahum gi angang chenbi nupi amabu pikliba angang adubu huntok hanlamlaga Mapuroiba puthoktribafaoba faduna thamgani haiduna yamna tamthiba Manipur Police ki moral sokpa yaba thabak ama Imphal East Dist. Ki SP amadi magi officer singna touraklibadu. Yamna Leibak Macha tadaba mapuroibana lalhoubu yaoraga nupi ,angang singda HUMAN RIGHTS violation touribadu BJP state Government na mityeng Changduna masida chennariba Police ki makokthongbasing 24 hours ki manungda Matik chaba Cheirak pidragadi.. Ee masel oiriba mathong huktaba police singgi eemung manung yaona party na khut thabagi yathang piragani. Party gi cadre surrender touhandraga makubok amadi nupi angang da akan singliba manipur Police ki moral sokpa yaba thabak touriba meewoi amatta lemna tharoi. Sirbasu hattoknaraga thawai thanabagidmak semsaduna leirey. Macha chenbi Nupi amadi mapa athubada BJP State Government na thadokadabani". That, the act of KCP MC Progressive is threatened to the Manipur Police specially SP -IE and Police officers and personnel of Porompat Police Station and their family members with intent to attempt the life of the Porompat Police personnel and their family members.

Hence a suo motto case under FIR No. 35(2)2025 PRT-PS u/s 351(3)/109/3(5) BNS-2023 and 20UA(P)Act has been registered for investigation.
