Sir,

I have the honour to state that today i.e. 11/04/2025 at about 02:00 pm, a reliable information was received from 4 AR and further corroborated from our own source regarding the presence of some active cadres of KCP (PWG) (a faction of KCP) organisation in and around Urup Awang Leikai area, Imphal East District under Iribung PS with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East Police Control Room at around 02:08 pm and conducted cordon and search operation at Urup Awang Leikai area. During that one unknown person was found at a house of one Md. Ibungo located at Urup Awang Leikai, Imphal East District in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Md. Ashadon (22 yrs.) @ Talip @ Laingam s/o Md. Inao of Urup Awang Leikai, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP(PWG) (a faction KCP) organisation and joined the said organisation in the year 2024 through one recruiter of KCP(PWG) organisation namely Lenin and he is presently working under the command of one s/s Commander Khaba of KCP(PWG) organisation from Wabagai who is also working as s/s Commander of a camp of KCP(PWG) organisation located at Heirok.

Hence, he was arrested from the spot at 04:20 pm by observing formalities.

Hence, the arrested person is handed over to you for taking further necessary legal action against him.
