Today i.e. 21/02/2025 at 9.00 pm one viral video post came across through Social Media such as Facebook and Whatsapp group suspected to be uploaded somewhere at Thlunungel Paton, within Bishnupur PS Jurisdiction in which one unknown person openly warned Manipur State Forces mainly Commando personnel whether they want to go home or not during off duties, whether they will ever return home if they continued to arrest Meitei/Meltei village volunteers. Some quotes from the uploaded video are as follows;

"Eikhoi Meitei Macha Maselgi Lan Oina Touba Pamira"

"Eikhoigi Commando Makheisina Eikhoi Meitei Gi Ichinao Khun Ngakpa Ngakta Onsillaga Pharibasidi Lasta Eikhoi Meitei Macha Lan Lakani"

"Commando Makhei Tao Noi Loina Nayumda Noi Suti Thokpa Ngamgadra-Ngamoidra? Noi Nayumda Hallaktaba Ngamoidra?"

"Mayang Machana Keidounungda Khangadaba Natte"

"Noina Lambi Thong Pumnamak Ching-Ching Puraga Noina Ichinao Pumnamak Leipham Pumnamk Noi Takthaoklidi Maramgino? Noida Kayan Kanaba Leige?"

"Noina Changba Ngamdaba Mapham Pumnamkata Khun Ngakpa Ichinao Pumnamakna Thoudang Yadana Changli. Noina Soti Tolop Ngai Leibani. Eramdam Manipurgi Damakta Ngak Senduna Karida Soigidage, Kadaida Kari Touri Ahing Tumba Chaba Khangd. Koichen Chendana ..."




