SP(L/O), Thoubal and under the overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police, Thoubal District were on patrolling at Waithou Ushoipokpi along NH-102. On reaching near Ushoipokpi bridge along NH 102 at around 7:00 a.m., some unknown persons were found standing with 2(two) MARUTI SWIFT ZXI white in colour b/regd. Nitaranjan Singh OC/CDO-TBL under the supervision of Shri. H. Devendra Singh Addl. SP(Ops), Thoubal under the overall supervision of Shri. Shivanand Surve, IPS, SP/Thoubal launched a massive operation at Krishnadas Farm House Heirok Part-III, Uyokching. Rabikumar Singh, IPS, SP/Bishnupur rushed at the said area.
