On 5/3/2025, an operation to destruct poppy cultivation was launched at around 8:00 am by a combined forces of Kangpokpi District, Police, 19 AR & 30 Bn. CRPF led by Syed Samir Ahamad, MPS, Addl.SP(Ops)/KPI assisted by Inspt. During the operation, approx. 10 acres of illicit poppy cultivation were detected in three separate area of the same hill range. The whole cultivation was destroyed and three(3) farm huts, fertilizers/chemicals used by cultivators were burnt at the spot. The approximate value of the destroyed is about Rs. 7,000,000/-(Seventy Lakhs)only. Hence the case.
