Sir,

I have the honour to submit the following report regarding joint field verification and destruction drive at suspected illegal poppy cultivation sites identified through satellite imaginary provided by the Narcotics Control Bureau (NCB).

On the 18th of April, 2025 at approximately 11.00 am, a combined team comprising personnel from Chakpikarong Police Station led by SI Hongsha Moshel in plainclothes and another team of 43rd Assam Rifles proceeded to the suspected location for ground verification and destruction of the illegal poppy crop. Upon reaching the area, it was observed that there was a deviation in the geographical coordinates as shared by the NCB. However, verification confirmed that the identified cultivation land of approximately 10 acres falls within the jurisdiction of L. Leisan village, Chandel district under the chieftainship of Alex Khongsai, within the police jurisdiction of Molcham Police Station, Khengjoi Sub-Division.

During inspection, it was found that the poppy latex had already been extracted at an unripe stage and the plants were observed to be dry and grey standing in the post-harvest fields. Some few poppy pods were seized and submitted to Molcham Police Station for further necessary action.

In the light of this, the team assessed that destruction was no longer feasible or necessary as the opium had already been collected. The team, therefore, returned without executing the destruction drive.

Photographs of the site have been enclosed for reference and confirmation that the poppy fields were indeed harvested during the last season. This report is submitted for your kind perusal and necessary action.
