Nikhil Singh** of CDO/IE Unit lodged a written report to OC/APS at 05:45 pm stating that on the 10th April, 2025 at about 10:00 a.m. received a reliable information from their own intelligence about the presence of some active members of the outlawed outfit RPF/PLA at Ngariyan Yairipok Road, Imphal East District. Based on the said information, a combined team of CDO/IE assisted by JC no. 731 Sub. K. Ibungobi Singh of 7th IRB/CDO/IE along with a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of



Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 10:40 a.m. As a part of the operation, random frisking and checking was conducted to the suspected passersby at Imphal Ngariyan Yairipok Road near Chingyang Lairembi Ima-Keithel. In that one suspected person was detained for spot checking and verification. On checking, one mobile phone was found and recovered from the possession of the detainee. On verification, the detainee identified himself as one Mutum Badal Mangang @ Badal Kamei @ Henry (40 years) S/o (L.) Makam Kamei of Uchathol, Jiribam District. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA joined through one Mr. Thoiba of RPF/PLA in the year 2007 and got his basic military training in the year 2009 at Myanmar with allotted army no. 3028 under the command of one Mr. Angou of RPF/PLA. He further stated that, he is presently working under the command of one s/s - Lieutenant Lanthaba of RPF/PLA. So, the detainee was arrested from spot i.e. Imphal Ngariyan Yairipok Road near Chingyang Lairembi Ima-Keithel at 11:40 a.m. and one mobile phone (Redmi C12) bearing IMEI no 868701061008995 & 868701061009001 along with one Airtel SIM card having mobile no. 8119965491 was seized from his possessions at the spot i.e. Imphal Ngariyan Yairipok Road near Chingyang Lairembi Ima-Keithel at 11:45 a.m. by observing due formalities. The arrestee is involved in transportation of arms and ammunitions and extortion of money from the general public, private schools and colleges located at Imphal areas. Therefore, the arrested person along with the seized mobile phone is being handed over to OC/APS for taking up further necessary legal actions against him. Hence, the case.
