Irengbam Chitaranjan of CID(S) Manipur**, Now attached with CDO/IE Unit lodged a written report to OC/APS at 01:20 pm stating that on the same day at about 12:30 a.m. received a reliable information about presence of some active members of the proscribed outfit KYKL SOREPA (Kanglei Yawol Kanna Lup - Socialist Revolutionary Party Kangleipak) at Andro and its adjoining area of Imphal-East District. Based on the said information, a combined team of CDO/IE and a column each of 4 AR and 33 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 2:00 a.m. In that, two unknown persons were detained for spot verification and checking at the hilltop of Andro Khuman Hill, Imphal East District. On checking their bodies, two nos. of mobile phones, one wallet and one sling bag were found and recovered. On verification, the detainees identified themselves as; (i) **Yumkhaibam Nanao Singh @ Parihan (27) S/o (Late) Y. Ningthemjao Singh of Andro Kharam Leikai, Andro Police Station, Imphal East District** and (ii) **Chingakham Norenkumar Singh @Korounganba (28) S/o Ch. Amujao Singh of Andro Sanapat, Andro Police Station, Imphal-East District**. On further verification, both the detainee stated that they are active cadres of the proscribed outfit KYKL (SOREPA) (Kanglei Yawol Kanna Lup - Socialist Revolutionary Party Kangleipak) and joined through one Mr. Thouba of KYKL (SOREPA) group in the month of September,



month of September, 2023 and presently working together along with one of their associate namely Mr. Premjit, under the command of one s/s - Lieutenant Mr. Roy of KYKL (SOREPA). They further stated that yesterday they along with the said Mr. Premjit, who is presently holding the rank of s/s - Second Lieutenant of their outfit stayed together at the spot i.e. hilltop of Andro Khuman Hill till 9:00 p.m. and he (Premjit) left them. So, both the detainees were arrested from the spot i.e. the hilltop of Andro Khuman Hill at 2:20 a.m. by observing due formalities. From the possession of the arrestee, Yumkhaibam Nanao Singh seized; (i) one mobile phone (Nokia TA-1575) bearing IMEI no. 352841372055980 without SIM card, (ii) one wallet containing one Driving License and (iii) one Sling bag were seized at the spot i.e. hilltop of Andro Khuman Hill at 2:25 a.m. by observing due formalities. One mobile phone (Samsung Galaxy A-13 IMEI NO. 3571575452/01 & 359025611575451 /01 along with Airtel SIM bearing mobile no. 9233964089 was seized from the possession of the arrestee Chingakham Norenkumar Singh at the spot i.e. hilltop of Andro Khuman Hill at 2:30 a.m. by observing due formalities.
