Sir,

I have the honour to state that today, i.e. 18/04/2025 at about 02:00 am, a reliable information was received from our own source and further corroborated from the information input provided by 33-AR regarding the presence of some active cadres of UPPK organisation (a faction of PREPAK organisation) in and around Yourabung area under Lamlai PS of Imphal East District with a view to commit prejudicial



ctivities like extortion of money from the general public and shops etc. Acting on the information, a I.I.F - 1team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted cordon and search operation at Yourabung Khunou area. During search at the house of one (Late) Ningthoujam Sengoi Singh located at Yourabung Khunou, Imphal East District, one unknown person was found in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and

During spot verification, he identified himself as Ningthoujam Sanathoi Singh (26 yrs.) son of the above mentioned (L) N. Sengoi Singh of Yourabung Khunou, Imphal East District.

On spot checking, the following articles were recovered from his possession:

- One Redmi 9A mobile handset along with one Airtel SIM card bearing mobile no. (i) 6909375769 (as disclosed by him)
- One Aadhaar card bearing no. 6047 0145 6830. (ii)

During preliminary verification, he disclosed that he is an active member of UPPK organisation (a faction of PREPAK organisation) and he started working for the said organisation since 2024 and he is presently working under the command of one s/s Commander Chalamba (Ph. No. 8132063209) of UPPK organisation and under the instruction of his s/s Commander Chalamba, he is involved in extortion activities by serving monetary demand to general public located in and around Imphal area. He further disclosed that he kept concealed some empty cases of different ammunitions, tactical gears and military uniform in his bedroom. As pointed out by him, the following articles were found which were kept concealed in his bedroom:

- One black plastic bag containing: (a) 44 (forty four) nos. of empty cases of .303 Rifle (i) ammunition, (b) 23 (twenty three) nos. of empty cases of 7.62 mm SLR Rifle ammunition and (c) 42 (forty two) nos. of empty cases of AK Rifle ammunition.
- (ii) One no. of camouflage helmet.
- (iii) One no. of tactical waist belt black in colour.
- (iv) Two nos. of knee cap/guard.
- (v) One no. of green colour pistol holster.
- (vi) One no. of Camouflage long pant.
- Two nos. of camouflage T-Shirt. (vii)
- (viii) One pair of boot.

And the above articles were recovered from his bedroom at his instance.

Hence, he was arrested from the spot at 02:55 am and the above recovered articles were seized at the spot at 03:02 am by observing formalities.
