Sir,

I have the honour to state that today, i.e. 18/04/2025 at about 02:05 am, a reliable information was received regarding the presence of some active cadres of KYKL organisation in and around Lamlai area under Lamlai PS of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted cordon and search operation at Lamlai Makha Leikai area. During search at the house of one Khaidem Modhuchandra Meitei located at Lamlai Makha Leikai, Imphal East District, one unknown person was found in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Khaidem Dhanabir Meitei (25 yrs.) son of the above mentioned Khaidem Modhuchandra Meitei of Lamlai Makha Leikai, Imphal East District.

On spot checking, the following articles were recovered from his possession:

- (i) One Redmi A3x mobile handset along with one Airtel SIM card bearing mobile no. 6909531475 (as disclosed by him)
- (ii) One Aadhaar card bearing no. 2495 5439 2816.

During preliminary verification, he disclosed that he is an active member of KYKL organisation and he is presently working under the command of one s/s Commander Korou of KYKL organisation and under the instruction of his s/s Commander Korou, he is involved in extortion activities by serving monetary demand to general public located in and around Imphal area since January, 2025. He further disclosed that he was instructed by his s/s Commander Korou to start annual collection from various government officials from the coming month of June, 2025 for their party fund.

Hence, he was arrested from the spot at 04:25 am and the above recovered article was seized at the spot at 04:32 am by observing formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
