Sir,

I have the honour to report that today i.e. the 18th April, 2025 at about 11:30 a.m. based on a credible information about the presence of some active members of the outlawed outfit PREPAK at Sanjembam Village and its surrounding area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a random frisking and checking to the suspected passersby at the tri-junction of Sanjenbam Shangshabi village, Imphal East District at 12:30 p.m.

In that, one suspected person was detained for checking and verification. On checking the detainee body, one mobile phone and one AADHAR card were found and recovered. On verification, the detainee identified himself as one Takhellambam Yaiphaba Meitei @ Nongdamba (26 years) S/o T. Toto Meitei of Keibi Kumuda Maning Leikai, Lamlai PS, Imphal East. On further verification, the detainee stated that he is an active cadre of the out outfit PREPAK joined through one Mr. Lainingthou of PREPAK in the month of May, 2023 and presently working under the command of the said Mr. Lainingthou of PREPAK.

So, the detainee was arrested from the spot i.e. tri-junction of Sanjenbam Shangshabi village, Imphal East District at 1:07 p.m. and seized one mobile phone (Lemon Anmol -211) bearing IMEI No. 911533300003165 & 911533300003173 without SIM card and one AADHAR cad at the spot i.e. tri-junction of Sanjenbam Shangshabi village, Imphal East District at 1:10 p.m.

Thereafter, the arrested person along with the seized mobile phone and AADHAR card is being handed over to you for taking up further necessary legal actions against him.
