Subject : Report

Sir,

I have the honour to report that today i.e. the 19<sup>th</sup> April, 2025 at about 5:30 a.m. based on a credible information from 5/9 GR about the presence of some active members of the outfit UNLF in and around Nongdam Village and its surrounding areas to carried pre-judicial activities like extortion of money from the general public. Based on the said information, a combined team of CDO/IE Unit 5/9 GR and a column of 8 Bn. Bihar Regiment assisted by Sub. N. Bobo Singh of 11<sup>th</sup> IRB/CDO/IE Unit and Sub. K. Ibungobi Singh of 7<sup>th</sup> IRB/CDO/IE Unit rushed to the said area and conducted C.I. Ops at Napetpalli Andro Road near Nongdam village, Imphal East District at 6:30 a.m.

In that, two suspected persons were detained for checking and verification. On checking the detainee bodies, two nos. of sling bags, two mobile phones and one wallet were found and recovered. On verification, the detainee identified themselves as ; **Yumnam Naocha Singh @ Mengba (24 years) S/o (L) Y. Subol**



**Singh of Nungoi Awang Leikai, Lamlai PS, Imphal East District and (ii) Heikrujam Bidyachandra Singh @ Bruce (28 years) S/o H. Ibotombi Singh of Lamlai Awang Leikai, Lamlai PS, Imphal East District.**

On further verification, both the detainees stated that they are active members of the outfit UNLF (Pambei) group joined through one Mr. Khaba of UNLF (Pambei) group and presently working under his command. Both the detainee further stated that on the instructions and advice of the said Mr. Khaba of UNLF (Pambei) group, everyday they use to collect extortion money from every commercial vehicles plying at Napetpalli Andro Road. They further stated that, today they were collecting extortion money from the vehicles plying at Napetpalli Andro Road, Imphal East.

So, the detainees were arrested from the spot i.e. from Napetpalli Andro Road near Nongdam village at 6:49 a.m. by observing due formalities and seized (i) *one mobile phone (Samsung Galaxy M24) bearing IMEI 35392734Q348834/01 & 356184811348830/01 along with one Airtel SIM card bearing no. 8991160990024097178U, (ii) One sling bag, black in colour, (iii) one wallet containing a sum of Rs. 1560/- (one thousand five hundred sixty rupees) and one AADHAR card* from the possession of the arrestee (Yumnam Naocha Singh) at the spot i.e. Napetpalli Andro Road near Nongdam village at 6:55 a.m. by observing due formalities. From the possession of arrestee, Heikrujam Bidyachandra Singh, (i) *one mobile phone (POCO F1) bearing IMEI no. 866021043168292 & 866021043168300 along with two SIM cards, Airtel - 8991160990026893902U and Jio - 89918650400302018777, (ii) One sling bag, brown in colour containing a sum of Rs. 2070/- (two thousand and seventy rupees)* were seized at the spot i.e. from Napetpalli Andro Road near Nongdam village at 7:00 a.m. by observing necessary formalities.

Subsequently, a stronger reinforcement team comprising of CDO/IE, LLI/PS, 5/9 GR and 8 Bn. Bihar Regiment were deployed to the area at 9:43 a.m. and recovered one SUV (Mahindra Bolero), white in colour, without regd. no. at 9:48 a.m. used by the accused persons for carrying out the said extortion activities from the spot i.e. Napetpalli Andro Road near Nongdam village, Imphal East District. The recovered SUV (Mahindra Bolero Power +SLX), white in colour, without regd. no. bearing Engine No. WGH6538385 and bearing Chassis no. MA1XL2WJXH5E38173 was seized from the spot i.e. Napetpalli Andro Road near Nongdam village, Imphal East District at 9:50 a.m.

Thereafter, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
