I have the honour to report that today i.e. the 20th April, 2025 at about 9:00 p.m. based on a credible information about the presence of some active members of the outlawed outfit PREPAK at Sawombung Thongkhong and its surrounding area of Imphal-East District. Based on the said information, a combined team of CDO/IE Unit and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C. I. Ops. at Sawombung Thongkhong Awang Leikai, Imphal East District at 10:00 p.m.

In that, one suspected person was detained for verification. On verification, the detainee identified himself as one **Khundrakpam Katho Singh (22 years) S/o (Late) Kh. Bir Singh of Sawombung Thongkhong Awang Leikai, Lamlai PS, Imphal East District**. On further verification, the detainee stated that he is an active member of the out outfit PREPAK joined through one Mr. Ningthem of PREPAK in the month of October, 2024 and presently working under his command.

So, the detainee was arrested from the spot i.e. Sawombung Thongkong Awang Leikai at 10:34 p.m. by observing due formalities.

Thereafter, the arrested person is being handed over to you for taking up further necessary legal actions against him.
