

On further verification, the detainee stated that he is an active member of the out outfit PREPAK joined through one Mr. Ningthem of PREPAK in the month of October, 2024 and presently working under his command.

So, the detainee was arrested from the spot i.e. Sawombung Thongkong Awang Leikai at 10:34 p.m. by observing due formalities.
