Subject: Report.

Sir,

1. Refer joint operation which was launched on 15<sup>th</sup> April 2025 in General Area Loushangkhong village where a suspected house was searched and no suspect was found in the house.
2. Continuous tracking of the suspected person was done by own source and on 22<sup>nd</sup> April 2025 at 1:30pm confirmed location of the suspect was shared, which was Yourabung village.
3. Based on the input, Lamlai Police Station was approached for joint operation for apprehension of the suspect. At 3:00 pm the input was shared with Lamlai Police team and by 4:30 pm a joint operation was launched with one team of Strength one officer, One JCO and 20 other ranks of 8<sup>th</sup> Bihar Regiment and two Police team under Miss S.Tryphena Reikhenamai, MPS-II (Proby), independent charge, OC-Lamlai Police Station with 10 (Ten) personnels and under SI N. Sudhir Singh of Lamlai Police Station with 7 (Seven) Personnels. A surprised check point (NAKA) was established at Napet Palli Bridge near DGR velocity KSK (Oil Pump) and on screening of personals and vehicles, a suspicious person with matching description as shared by own source was initially detained. On further questioning and enquiry, the suspected person identified himself as Mr. **Wangkheirakpam Nandi Singh (42) yrs S/O (L)W. Chandramani Singh of Loushangkhong Makha Liekai, Imphal East District**, who was an active member of "PREPAK". The individual was arrested on the spot at 5:17 pm and was taken to Lamlai Police Station. The operation was called off at 5:30 pm.
4. Therefore, the arrested cadre is being handed over to you for taking up further necessary legal action against him.
