Sir,

I have the honour to report that today i.e. the 23rd April, 2025 at about 2:00 a.m. received an information from a reliable source about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Napetpalli, Imphal East District. In the meantime, further information was received that the unknown arm miscreants shifted the arms, ammunitions and explosives to Pourabi Village, Imphal East District. Based on the said information, a combined team of

CDO, Imphal-East District and a column of 8 Bihar Regiment under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal East District rushed to the said area and conducted a searched operation in the general area Pourabi village and its adjoining areas of Imphal East District at about 3:40 a.m.

During the search operation, found one sack bag suspected to be containing arms, ammunitions and explosives hidden in a bush at the foothill of Pourabi village Lai Ching, Imphal-East. On opening the sack bag the undernoted arms, ammunitions, explosives and other items were found and recovered;
