I have the honour to report that today i.e. the 24<sup>th</sup> April, 2025 at about 11:00 a.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outlawed outfit KCP at Sawombung – Phaknung Sangomshang Village, Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted C. I. Ops. at the said area at about 12:00 noon.

a part of the searched operation, random frisking and checking was conducted to the suspected passersby PhaknungSanghomshang near Mine B Football Turf ground, Imphal East. In that, one suspected person was detained for spot checking and verification. On checking his body, one mobile phone was found and recovered. On verification, the detainee identified himself as one Yaikhom Kiran Meitei (28 years) S/o Yaikhom Deben Meitei of PhaknungSangomshang, Imphal East District.

On further verification, the detainee, stated that he is an active member of the outfit KCP (City Meitei) group joined through one Mr. Robertson of KCP (City Meitei) in the month of July, 2024. He further stated that, he is presently working under the command of one said s/s – Lieutenant Max of KCP (City Meitei) group. So, the detainee was arrested from the spot i.e. PhaknungSangomsangnear Mine B Football Turf ground, Imphal East at 12: 46 p.m. and seized one mobile phone (Redmi 12) bearing IMEI no. IMEI no. 866149067220283 & 866149067220291 along with one Jio SIM card bearing no. 89918650400090263122 from his possession at 12:50 p.m. by observing due formalities.

On further examination of the arrestee, Yaikhom Kiran Meitei, it came to learnt that one of his associate is waiting for him at Sawombung Khunjao, Imphal East. Immediately, our team along with the arrestee rushed to Sawombung Khunjao, Imphal East and conducted a mass searched operation by cordoning the area. Our CDO teams conducted the C.I. Therefore, the arrested persons along with the seized scooter and mobile phones are being handed over to you for taking up further necessary legal actions against them.
