Sir,

I have the honour to report that today i.e. the 25th April, 2025 at about 2:20 a.m. received a reliable information about presence of one active member of the outlawed outfit PREPAK at Tellou village of Imphal-East District. Based on the said information, a combined team of CDO/IE and a column of 8 Bihar Regiment under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 3:10 a.m.

In that, one suspicious unknown person was detained for spot verification at Tellou Mamang Leikai near Pukhri Achouba, Imphal East District. On verification, the detainee identified himself as one Elangbam Langamba Meitei @ Ibungo (25 years) S/o E. Mani Meitei of Tellou Mamang Leikai, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit PREPAK (Pro) joined through one through Mr. Mexico of PREPAK (Pro) in the month of October, 2024. The arrestee further stated that he is presently working under the command of the siad Mr. Mexico of PREPAK (Pro).

So, the detainee was arrested from the spot i.e. Tellou Mamang Leiaki near Pukhri Achouba, Imphal East District at 3:52 a.m. and seized one wallet containing one AADHAR card from his possession at 4:00 a.m. from his possession by observing necessary formalities.

Therefore, the arrested person along with the seized item is being handed over to you for taking up further necessary legal actions against him.
