I have the honour to report that today i.e. the 26<sup>th</sup> April, 2025 at about 3:00 a.m. received a reliable information about presence of one active member of the outlawed outfit KCP at Nongren Village, Imphal-East District. Based on the said information, a combined team of CDO/IE and 8 Bihar Regiment under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 4:00 a.m.

In that, one suspicious unknown person was detained for spot verification at Nongren Mamang Leikai, Lamlai PS, Imphal East District. On checking his body, two nos. of mobile phones were found and recovered from his possession. On verification, the detainee identified himself as one Ningthoujam Birjit Meitei @ Kanba @ Tocha (36) S/o N. Doneshwor Meitei of Nongren Mamang Leikai, I mphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) joined the outfit through one Mr. S.K. @ Taton of KCP (PWG) in the month of January, 2024. He further stated that, he is presently working under the command of the said Mr. S.K. @ Taton of KCP (PWG). So, the detainee was arrested from the spot i.e. Nongren Mamang Leikai, near Community Hall, Lamlai PS, Imphal East District at 4:35 a.m. and seized; (i) One mobile phone (OnePlus Nord CE Lite 5G) bearing IMEI no. 861797077867090 & no. 861797077867082 along with two SIM cards bearing no. Jio-89918650400129635217 and Airtel – 89960990020779090U and (ii) One mobile phone (CELLECOR X 4+) bearing IMEI no. 350635169098 & 350635169098 along with two Airtel SIM card bearing no. 8991160990021627858U & 8991560990038551797U-H1 from his possession at the spot i.e. Nongren Mamang Leikai near Community Hall, Lamlai PS, Imphal East District at 4:40 a.m. by observing necessary formalities.

Therefore, the arrested person along with the seized mobile phones is being handed over to you for taking up further necessary legal actions against him.
