Sir,

1. Refer joint operation which was launched on 26th April 2025 in General Area of Sawombung village where an input of likely presence of cadre of banned outfit was received.
2. Continuous tracking of suspected person was done by own source and confirmed his presence in general area of Sawombung.
3. Based on the input, Lamlai Police Station was approached for joint operation for apprehension of the suspect. At 1600 hrs input was shared with Lamlai Police team and by 1830 hrs a joint operation was launched with one column of 8th Bihar Regiment under officer and a team of Lamlai Police. A surprised check point was established at Sawombung junction near FCI and on screening of personals and vehicles, a suspicious person with matching description as shared by own source was detained. On further questioning and enquiry, the suspected person identified himself as **Mr. Laishram Suraj Singh (28) yrs S/O L. Kumar Singh of Naoremthong Laishram Leirak, Lamphel PS, Imphal West District**, who was an active member of KCP (PWG). The individual was arrested on the spot at 6:47 pm and was taken to Lamlai Police Station. The operation was called off at 7:00 pm.
4. Therefore, the arrested cadre is being handed over to you for taking up further necessary legal action against him.
