

I have the honour to report that today i.e. the 27<sup>th</sup> April, 2025 at about 12:00 noon received a reliable information from FGT (Field General Team), Imphal BSF corroborated with our own intelligence about the presence of some active members of the outlawed outfit KCP at Sawombung aera of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 164 Bn. BSF, Koirengei under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted C.I. Ops. at the said area at about 1:00 p.m.

In that, two suspected unknown persons were detained for verification and checking. On checking the first detainee, one mobile phone, one wallet and one car key were found and recovered. On verification, the identified himself as one Shagolshem Lemba Meitei (43 years) S/o (Late) Sh. Pakpa Meitei of Loushangkhong Makha Leikai, Lamlai PS, Imphal East District.

On checking the second detainee, one mobile phone and one wallet were found and recovered. On verification, the second detainee identified himself as one Shagolshem Romen Meitei (40 years) S/o Sh. Ibohalbi Meitei of Loushangkhong Makha Leikai, Lamlai PS, Imphal East District.

On further verification, both the detainees stated that they are active members of the outfit KCP (Noyon) group joined through one Mr. Puyam Joy of KCP (Noyon) in the month of July, 2023. The detainees further stated that, they are presently working under the command of the said Joy of KCP

doyon). They further stated that, they were involved in collection of money for raising their party fund on the advice of the said Mr. Puyam Joy of KCP (Noyon).

So, both the detainees were arrested from the spot i.e. Sawombung Gate near Forest Office at 1:54 p.m. by observing necessary formalities.
