Subject: Report.

Sir,

I have the honour to report that today i.e. the 5th May, 2025 at about 6:00 a.m. received a reliable information about presence of one active member of the outlawed outfit RPF/PLA at Sawombung Khunjao, Imphal-East District. Based on the said information, teams of CDO/IE Unit comprising of Jem. Md. Amir Sultan of 1st MR/CDO/IE, ASI. Md. Sakir Ahamed of CDO/IE Unit, Hav. Kiran Heisnamba of 7th MR/CDO/IE and HC N. Somorjit Singh of CDO/IE under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 7:00 a.m.

In that, one unknown suspected person was spotted walking hurriedly as if he was trying to escape from the eyes of our CDO personnel at Sawombung Kabui Khunjao, Lane no. 18, Imphal-East District. Noticing the suspicious nature of the unknown man, our CDO personnel approached towards the unknown suspected person to detained and make verification. To this, the unknown suspected person take out his weapon (Pistol) and fire-out one round (bullet) towards our CDO personnel and started running away from the spot. Immediately, our CDO personnel took positions and chased the escaping unknown armed suspected person. After chasing about a distance of 300 meters, our CDO personnel overpowered the escaping unknown suspected person and put under control. From his possession, one pistol loaded with 8 (eight) live rounds in the magazine was found and recovered.

On verification, the detainee identified himself as **Moirangthem Oken @ Somorjit** (aged about 55 years) S/o M. Ibomcha Singh of Khurai Kongpal Laishram Leikai, Porompat PS, Imphal East District an active cadre of the outfit RPF/PLA joined through one Mr. Suresh @ Bheiya in the year 1993. He further stated that he got his basic military training in the same year at Choto Dhamai, Bangladesh for 45 days under the command of one s/s – Lance Corporal Joy of RPF/PLA with army no. 448 of 11th batched. He further

ated that he is presently holding the rank of s/s - Lance Corporal working under the command of s/s - Major Mr. Khelemba of RPF/PLA.

So, the detainee was arrested from the spot i.e. Sawombung Kabui Khunjao, near Sawombung bridge Imphal-East District at 7:36 a.m. and seized one 9 mm Pistol marked as '*Pistol AUTO 18306076*' loaded with eight live rounds in the magazine by observing due formalities at 7:38 a.m.

On further examination, it came to learnt that the arrestee had throw away his sling bag, containing one hand grenade, one 9 mm pistol magazine with ammunitions, mobile phones etc. while he was being chase by our CDO personnel. Immediately, our CDO team along with the arrestee searched the escaping routes along with the arrestee. On the instance and pointing of the arrestee, *one sling bag, black in colour, containing: (i) one No. 36 hand grenade, (ii) one detonator, (iii) one 9 mm pistol magazine with five live rounds, (iv) one mobile phone (Redmi not 10 lite) bearing IMEI no. 865397051284697/00 & 865397051284705/00 along Airtel SIM card bearing mobile no. 8413843193, (v) one mobile phone (POCO C61) bearing IMEI no. 869742071738782 & 869742071738790 along with one Airtel SIM card bearing mobile no. 8132063312, (vi) one mobile phone (Xiaoping 11) bearing IMEI no. 869406058962910/78 & 869406058962928/78 along with one Airtel SIM card bearing mobile no. 8132035721 and (vii) one wallet containing one AADHAR card* were recovered and seized from Sawombung Kabui Khunjao, near the tri-junction of Lane no. 18, Imphal East District at 7:38 a.m. by observing due formalities.

On further verification, the arrestee sated that he was involved in extortion of a huge amount money for raising their party fund on the advice and instruction of the said Mr. Khelemba of RPF/PLA.

Thereafter, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
