Thoiba Singh of Pourabi Mayai Leikai 3) Thingbaijam Naoba Singh (22) S/o Th. Inaocha of Pourabi Makha Leikai 4) Yambem Basker Singh (21) S/o Y. Priyokumar of Pourabi Makha Leikai 5) Loitongbam Borish (21) S/o L. Engo Singh of Pourabi Mayai Leikai 6) Nongthombam Naocha (21) S/o (L) N. Ritu of Pourabi Makha Leikai.
