I have the honour to report that today i.e. the 8th May, 2025 at about 1:00 p.m. received a reliable information about the presence of some anti-social elements suspected to be members of the proscribed outfit KCP at Nongren Village, Imphal East District. Based on the said information, a combined team of CDO/IE Unit & 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted searched operation 2:10 p.m.

In that, one unknown suspected person was detained for spot verification and checking at his residence at Nongren Maning Leikai, Imphal East District.

While the unknown person was being detained and trying to check and verified, a large number of mob approached towards our CDO team and enquired why the detainee is being detained. The behaviour of the detainee seems very disturbing and perturbed and this attracted suspicion. Considering the situation and importance of further verification, our CDO personnel further detained the unknown person and immediately bring out from his residence to a safer place for verification and checking. On reaching, Napetpalli near Forest Office, Imphal East, verification and the checking of the detainee was conducted.

On checking his body, one mobile was found and recovered from his possession. On verification, the detained identified himself as one Hidam Aboy Singh @ Atapa (30 years) S/o – (Late) H. Herabi Singh of Nongren Maning Leikai, Lamlai PS, Imphal-East District an active cadre of the outfit KCP (Noyon)/MFL group joined in the year 2012 and got his basic military training in the same year under the command of one s/s – Sergeant Major Mr. Japan of KCP (Noyon)/MFL group for 45 days at Tanal, Myanmar of 22nd batched. He further stated that, he is presently holding the rank of s/s – Private and working under the command of one s/s – Lieutenant Mr. Uttam of KCP (Noyon)/MFL group.

So, the detainee was arrested from the spot i.e. Napetpalli near Forest Office, Imphal East at 3: 10 p.m. by observing due formalities and seized one mobile phone (POCO C50), bearing IMEI no. 868492061126546 & 868492061126553 along with one Airtel SIM card bearing mobile no. +91 8730947190 at the spot i.e. Napetpalli near Forest Office, Imphal East at 3: 15 p.m. by observing due formalities by observing due formalities.

Thereafter, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal procedures against him.
