Sir,

I have the honour to report that today i.e. the 11th May, 2025 at about 1:00 p.m. received a reliable information about presence of one active member of the outlawed outfit KCP at Khurai area of Imphal-East District. Based on the said information, a combined team of CDO/IE Unit & 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 2:00 p.m. at Khurai Angom Leikai, Imphal-East District.

In that, one suspicious unknown person was detained for spot verification at Khurai Angom Leikai, Imphal East District. On verification, the detainee identified himself as one **Ngangom Rabi Singh @ Nganba (46) S/o Ng. Muhindro Singh of Khurai Thangjam Leikai, Leimapokpam Leirak, Porompat Police Station, Imphal East District.** On further verification, the detainee stated that he is an active cadre of the outfit KCP (PWG) group joined through one Mr. Micheal of KCP (PWG) group in month of September, 2023 and presently working under his command. He further stated that, on the advice of the said Mr. Micheal he had extorted a huge amount of money from various Oil Pumps located at Imphal area for raising their party fund.

So, the detainee was arrested from the spot i.e. Khurai Angom Leikai, Imphal East District at 2:42p.m. by observing due formalities and seized one mobile phone (Redmi 12C) bearing IMEI no. 8861612067480756 & 86162067480764 along with one Airtel SIM card bearing mobile no. +91 70855 36354 from his possession at the spot i.e. Khurai Angom Leikai, Imphal East District at 2:45 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
