Sir,

I have the honour to report that, I have investigated a UD case having No. 03/NBL-PS/2025 Dated 07/03/2025 U/S. 194 BNSS regarding the suspected dead of one female namely Thokchom (O) Matouleibi Devi, aged about 31 years W/O Thokchom Tomba Singh of Malom Tulihal, Imphal West District in the intervening night of 6th and 7th March, 2025 which was found afloat in the public pond located at Malom Terakha.

During the course of investigation, visited the spot and inspected minutely with the help of a mobile team of District Mobile Forensic Unit, Bishnupur in presence of the concerned Executive Magistrate, Hiyangthang. The spot was photographed from different angles and also drawn a rough sketch map of the P.O. with proper index. Seized some water sample marked as "A" collected from the pond and one red colour right side chapal marked as "B" collected from the pond. The dead body was kept at RIMS Mortuary for PM examination by observing formalities. On the same day i.e. 07/03/2025, conducted PM examination in presence of the Executive Magistrate with video coverage with consent of family members of parental and matrimonial families of deceased woman. At the RIMS Mortuary seized (1) one white round neck slur sweater, (2) one light pink bra, (3) one maroon colour phanek, (4) one black colour full length thermal pant, (5) one light blue colour floral print half slur top, (6) one labelled and sealed white envelope containing nail clipping of both side, (7) one sterile plastic container with Urethral swab labelled and sealed (8) one sterile plastic container with vaginal swab labelled and sealed (9) one labelled and packed plastic pouch containing scalp hair, (10) one labelled and packed plastic pouch containing blood on a piece of cloth, (11) one labelled and packed plastic pouch containing sample of seal, (12) one labelled packed and sealed glass jar containing stomach and its contents and a part of small intestine, (13) one labelled packed and sealed glass jar containing a piece of liver with gall bladder, half of each kidneys, (14) one labelled packed and sealed glass bottle containing blood without preservative, (15) one labelled packed and sealed glass bottle containing sample of preservative (saturated solution of common salt) and (16) one recorded San Disk Ultra SDHC, UHS-I Memory Card 32 GB packed and sealed in a brown envelope by observing all due formalities. After completion of PM examination, the parental family of the deceased refused to take the mortal remains of the deceased for her final rites as they have suspicious that the death might happen due to mental and physical torture by her husband and his family members. So, the corpse was again deposited at RIMS Morgue on requisition.

During preliminary investigation, it is ascertained that the deceased woman has spent most of the time in a passionate life style while she was alive. Her husband, sisters and brothers-in-laws have frequently scolded and assaulted for her easy life style. So, it is highly suspected that the deceased woman took the extreme step of ending her life by drowning due to physical and mental

Since the deceased is suspected to have died due to the physical and mental harassment/torture by the family members of matrimonial home of the deceased woman which is tantamount to an offence under section 108/85/3(5) BNS, the present U.D case is required to be converted into a regular FIR case for proper investigation.
