Sir,

I have the honour to report that, I have investigated a UD case having No. 01/NBL-PS/2025 Dated 07/01/2025 U/S. 194 BNSS regarding the dead of one female inmate of Mekola relief camp identified as one Sukham Ongbi Chanu Devi, aged about 20 years W/O Sukham James Singh of Singhat, Churachandpur District A/P Relief camp Mekola Gulap Higher Secondary School by hanging inside her room using cloth (Chuni).

During the course of investigation, visited the spot and inspected minutely with the help of a mobile team of District Mobile Forensic Unit, Bishnupur and Executive Magistrate, Hiyangthang. The spot was photographed from different angles and also drawn a rough sketch map of the P.O. with proper index. Seized one MI Phone golden in colour along with one sim card of Airtel having mobile number 7627992397, two nos. of chunis white and red colour having 70 inches & 62 inches respectively and one Diary pink in colour marked as "NOTES" from the spot. The dead body was kept at RIMS Mortuary for PM examination by observing due formalities. On 08/01/2025 conducted PM examination in presence of the concern Executive Magistrate with video coverage with consent of family members of parental and matrimonial families of deceased woman. Seized one pouch containing nail clapping of both side, one sterile tube containing vaginal swap, one sterile tube containing urethral swap, viscera and one recorded San Disk Ultra Memory Card 32 GB by observing formalities. After completion of PM examination, the parental family of the deceased refused to take the mortal remains of the deceased for her final rites as they have suspicious that the death might happen due to mental torture by her husband and his family members in connection with her stridhan property. So, the corpse was again deposited at RIMS Morgue on requisition.

During preliminary investigation, it is ascertained that the family members of the in-law of deceased woman have been taking shelter at the Relief camp, Mekola Gulap Hr. Secondary School since the 26th August, 2023 due to the ongoing turmoil law and order situation in the state. After being eloped twice with Sukham James Singh and the deceased since 4 (four) months back, they have been staying at the relief camp as husband and wife without performing any form of marriage ceremony. Due to the displacement and poverty, there were frequent family dispute between them including family members.

In further course of investigation, on 08/01/2025 at 11:00 am the elder brother of deceased woman namely Sinam Kangleinganba Meitei, 32 yrs S/O (L) Sinam Mani Meitei of Chingmeirong Lei Ingkhol, Imphal East District had submitted a report under G.D. entry No. 18/NBL-PS/2025 dated 08/01/2025 regarding the suspicious death of his younger sister at her in-law's place at relief camp on 07/01/2025 at around 4:15 pm. He stated that, it is highly suspected that his younger sister has been mentally tortured frequently by her husband (Sukham James), elder brother-in-law (Sukham Ningthem) and father-in-law (Sukham Chaothoi) to bring stridhan property at the earliest as they did not perform her marriage ceremony formally due to eloping twice. However, the family members of Sukham James keep on pressuring his deceased younger sister to inform her parental home for performing Loukhatpa ceremony and to provide her stridhan properties. He further stated that

he along with his family were unable to fulfil their demand intimated through his deceased younger sister as their mother had expired due to cancer soon after her elopement. They strongly believe that his younger sister took the extreme step of ending her life by hanging due to their mental torture and dowry demand.

Since the deceased is suspected to have died due to the mental harassment/torture and dowry demand. by the family members of matrimonial home of the deceased woman which is tantamount to an offence under section 80 & 3(5) BNS, the present U.D case is required to be converted into a regular FIR case for proper investigation.
