Sir,

I am to report that today i.e. 05/04/2025 at around 3.15 pm based on the reliable input provided by 10 BN BSF and corroborated with own source regarding loitering of some armed miscreants in and around Potshangbam, Toupokpi & Ningthoukhong area and carrying out extortion activities, a joint team of team of CDO/BPR led by self-assisted by Hav. No. 411811 Th. Basanta Singh under the command of Sub. Y. Shaktishen Singh, OC-CDO Bishnupur, under the supervision of Amarjit Singh Lamabam, MPS, Addl. SP (Ops) Bishnupur and overall guidance of Ksh. Ravikumar Singh, IPS. SP-Bishnupur immediately rushed to the said area and conducted search operation, random frisking and checking at the suspected areas to nab the culprits.

During the search operation, one unknown individual was seen moving in suspicious manner along Tiddim road near Potshangbam Playgroud, Accordingly the team detained the suspect for verification. The individual was examined thoroughly at the spot. On examination, he identified himself as Hemam Priokumar Meitei @ Irikkhomba (32) S/O. (L) H. Noren Meitei of Moirang Panshang Leiakai ward no.1 A/P. Moirang College gate an active cadre of KCP(PWG) outfit involved in extortion activities at Bishnupur and Nambol area. Further he disclosed that he is presently working under the command of S/S Major Loveson @ Nimai of the outfit. Hence he was arrested on the spot at 3.55 pm and also seized 01(one) One Plus Nord CE 2 mobile phone steel in colour along with one airtel SIM card bearing no.7628062813 from his possession at 4.05 pm by observing the formalities.

Therefore, the arrested person along with the seized items and seizure and arrest memos were handed over to you for taking further necessary legal action against him
