Sir,

With due respect, I have the honour to state that I am the Proprietor of Sunrise Indane Gramin Vitrak, Registered under DC/(CCP)/J01/IOC/2013-1, which was located at Parbung village, Pherzawl District, Manipur, and I have started my business by way of distribution of gas amongst the general public since 2014 in collaboration with Mr.Sougaijam Lalmohon Singh(Ph.8974775999/7005546742) of Ngaikhong Leikai Bishnupur District and we run the business smoothly until the communal clash broke out on 3rd of May, 2023. I could not contact my business partner Mr.Sougaijam Lalmohon Singh of Ngaikhong Leikai Bishnupur District since the month of August 2023, and my Gas Cylinder (filled Gas Cylinder 458 in numbers and Empty Gas Cylinder about 917 in numbers) were in his custody. Being a business partner I was in the opinion that he will be keeping safely in view of continuing the business where there is a peaceful atmosphere with the state. That on the 28th December 2024 I got call from from the Head Office at Shilchar and I was questioned the whereabouts of the gas cylinders. And it came into light that my gas cylinders were missing. So, I have reported the matter to you for tracing out the missing cylinders and the culprits since it was not longer in the custody of my manager Mr. Sougaijam Lalmohon Singh.

That it may reported here that the above mentioned cylinders (Filled as well as empty cylinders) which had been untraceable till date is estimated to be Rs.35,86,460(rupees thirty five lakhs eighty six thousands four hundred and sixty)only.

That I am filling this information lately because In got the information only in the month of December 28th of 2024 that the above mentioned cylinders could not traced anymore.Thereafter I have been trying to confirm about the same till recently and thus, I am filing the report lately today.

In the given circumstances, I hunbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per prevailing provisions of the laws of country. And for which act of kindness, I shall always remain thankful to you and obliged.
