

Sir, I am to report that today i.e. 29/04/2025 at around 6.30 am based on the reliable input from own source regarding about the movement of some armed miscreants in and around the general area of Kwaksiphai Mayai Leikai area who were threatening general public, local businessman, shopkeepers etc. to extort money. Based on the input, a combined team of CDO/BPR led by self including women police and assisted by Hav. S. Hemanta Singh, Hav. Ch. Bobo Singh, Hav. Samuel Kamei under the command of Sub. Y. Shaktishen Singh, OC-CDO Bishnupur, under the supervision of Shri Amarjit Singh Lamabam, MPS. Addl. SP (Ops) Bishnupur and overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur immediately rushed to the said area and conducted search for the suspected person.

She is an active cadre of banned unlawful organisation KCP(PWG) working under the command of one Khullakpa of KCP (PWG) and was involved in extortion and monitary demand from the general public local bussinessman and shopkeepers of Thoubal area. Hence, she was arrested at the spot at 7.33 am from Kwakshiphai Mayai Leikai and one mobile handset model Redmi note 12 pro with 2(two) sim card (Airtel- 9612225331 & Jio-9366804482) was recovered and seized at 7.38 am. Unfortunately, the team left the spot for CDO complex, Tera Urak as the local populace started gathering to create public mob. So, the required formalities were completed later at CDO complex.

Therefore, the arrested person along with the seize items, seizure memo and arrest memo is being handed over to you for taking further necessary legal action against her.
