Sir,

I have the honour to report that on 29/04/2025 at around 10.00 am, received a reliable input from own source regarding movement of armed miscreants at Nachou Patangkhang area in between Nachou Patton and Ningthoukhong Patton Mamang. Based on the information, a joint team of CDO-BPR under the command of Shri Amarjit Singh Lamabam, MPS, Addl SP(Ops)/BPR, Shri P. Sanjoy Singh, MPS, DSP(CDO-I)/BPR and Sub. Y. Shaktishen Singh OC/CDO-BPR assisted by SI N. Nandalal Singh, SI Ph. Sunil Singh, SI S. Ojit Singh, ASI M. Romesh Singh, Hav. Kh. Kunje Singh, Hav. Ch. Bobo Singh along with a column of 5 Sikh led by Major Lokpal Singh under the overall guidance of Shri. Ksh. Ravikumar Singh, IPS, SP-BPR immediately rushed to the said area in presence of Shri P. Rakeshchand, SDC/Executive Magistrate, Bishnupur and conducted an extensive search operation by cordoning the suspected floating huts to prevent any unwanted activities.

During the course of cordon and search operation, tactically by the combined team in between Nachou Patton and Ningthoukhong Patton Mamang, around 30 floating huts were cordoned and searched. During the search operation in one of the hut at Nachou Patangkhang area, the combined team came across one hut which was suspected to be used by KCP(PWG) as their camp hideout. However, as they might fled the area on seeing the approaching teams. The joint team successfully recovered the undernoted incriminating articles which were kept concealed under the floating Phumdis inside a rubber tube and from one gunny sack white in colour.
