Sir,

I am to report that, today i.e. 07/05/2025 at around 12.45 pm received an input from 19 AR corroborated with own source regarding presence of some active cadres of valley based UGs at Ningthoukhong Kha Keirungba Leikai, ward no. 7 area who were involved in extortion and threatening Government office, general public, local businessmen e.t.c. Based on the input combine teams of CDO/BPR led by self assisted by Hav. RK Manjit Singh under the command of Inspt. W. Ibomcha Singh, i/c OC-CDO Bishnupur under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops) Bishnupur under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur immediately rushed to the said area and conducted cordon and search at some suspected houses.

During the course of search at one of the house, one unknown individual was detained on suspicion. On spot verification, the unknown person identified himself as Khundrakpam Naresh Singh @ Boicha (30) S/O Kh. Nobin Singh of Ningthoukhong Kha Keirungba Leikai, ward no. 7. On examination, he disclosed that, he is an active cadre of KCP(PWG) joined in the month of July, 2023 through one Mangang of KCP(PWG) and had alloted army no. 295. He further disclosed that, he is working under one Langamba of KCP(PWG) and under the instruction of Langamba he had collected 50(fifty) nos. of tracksuit from Bishnupur Bazar Board in the month of September, 2023 and 02(two) nos. of Sintex (500 litres), 02(two) nos. of Gas Stove, wires and cloths from Moirang Bazar Board in the month of October, 2023 and handed over to Langamba. Further he had also served monetary demand at Kwakeithel, Kakwa and Ngaikhong under the instruction of Langamba. Hence, he was arrested from Ningthoukhong Kha Keirungba Leikai, ward no. 7 (his residence) at 1.42 pm and seized one Realmi Narzo N53 mobile phone having two Jio SIM cards bearing mobile no. 9863275959 and 8638194617 from his possession at 1.47 pm by observing proper formalities.

The arrested person along with the seized item is handed over to you for taking further necessary legal action against him.
