Today i.e. 12/01/2024 at 09:40 am received a reliable difformation that on the same day at about 9:35 am one TVS Jupiter bearing Regd. No. MN065K-3327, blue in colour, ridden by one unknown rider which was proceeding from Nambol aide towards Imphal side dashed to the right backside of one Bajaj RE Auto Rickshaw bearing Regd. No. MN06SA-2966 driven by one unknown driver which was also proceeding from the same direction at Khori Leikai in front of Nambol Leiren Girls' High School along Tiddim road due to rash and negligent driving on the part of both the unknown driver of Bajaj RE Auto Rickshaw and rider of TVS Jupiter Scooter As a result of which the unknown rider and pillion rider of TVS Jupiter scooter received sustained injuries on their persons and evacuated to hospital for medical treatment. And both the vehicles were also partly damaged.
