I have the honour to state that today i.e. 13/05/2025 @ 11:30 am, while conducting a random frisking and checking along NH-2 below Mt. Everest College, Senapati District, Manipur by a joint team of Senapati Police Special Operation Team, Senapati Women Police and 1-Sec. of D-78 CRPF, one passenger vehicle Tata Winger bearing Regd. No. MN 01BA-0274 was seen coming from Imphal side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as MD. Imaran Hussain (36) yrs s/o MD. Fajur Rahman of Uripok Tuliha, Manipur. On checking the vehicle, one carry bag (black in colour) marked as Hong Fu was found at the back seat of the said vehicle. On further enquiry, Nemjahoi Baite (38) yrs d/o Saiminlen Baite of N. Terakhong, Laikoiching, P.O: Lamlong, District: Senapati stated that the carry bag belongs to her. On checking the carry bag, suspected brown sugar was found inside the carry bag. Following which, the said person was detained. As such DC/SPT was intimated and a request was made to depute one magistrate. Accordingly, SDC/SPT Shri. Panii Ngaonii (34) yrs (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate, in his presence, the said bag of Nemjahoi Baite (38) yrs c/o Saiminlen Baite of N. Terakhong, Laikoiching, P.O: Lamlong, District: Senapati, Manipur was thoroughly checked. On checking, 6(Six) packages suspected to be brown sugar was found inside the bag.
