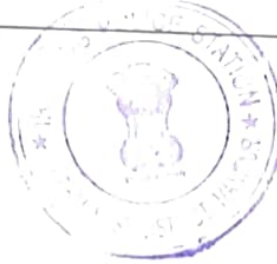

Subject :- Report.

Sir,

I have the honour to report that today i.e. 16/05/2025 at about 4:30 pm, received reliable information about the concealment of arms and ammunitions in Nungjenbi Urup Hill Range by unknown armed miscreants. Based on the said information, a combined team of Irilbung Police team led by Shri. Noor Kamaal Sheikh, (MPS) Independent charge, OC-IBG/PS and a column of 4 AR (COB) Lilong along with myself under the supervision of Shri P. Sankar Singh (MPS), Addl. SP (Law & Order), Imphal-East, Shri Y. Joyraj Singh (MPS), Addl. SP (Ops) Imphal-East, Shri M. Digbijoy Meetei, MPS, SDPO-PRT, Imphal-East and overall supervision of Shri. Rakesh Balwal, (IPS), Sr. SP, Imphal-East District Manipur had conducted a search operation in the general area of Nungjenbi Hill, Urup Chingon, Imphal-East District and its adjoining areas of Imphal-East District at around 5:00 pm.

During the search operation, found a white sack bag suspected to contain arms and ammunitions hidden in the bushes of Nungjengbi Urup Hill, Urup Chingon, Imphal-East District. On opening the sack bag the undernoted arms and ammunitions were found and recovered;

- 1) 1 (one) 303 rifle bearing 60244X along with magazine,
- 2) 1 (one) 9 mm pistol along with 3 magazines,
- 3) 6 live rounds of 9mm ammunitions,
- 4) 1 countrymade pistol,
- 5) 3 (three) nos of 303 LMG magazines,
- 6) 7(seven) nos. of Carbine Magazines,
- 7) 5 nos of normal tear smoke shell,
- 8) 2 nos. of tear chilli smoke shell,
- 9) 2 nos of wireless set battery (Motorola),
- 10) 6(six) nos. of tube launching (mini flare),
- 11) 6 (six) live rounds of 7.62 ammunition,
- 12) 19 (nineteen) live rounds of AK-47 (5.56 mm),
- 13) 1 (one) wood pressing shell,
- 14) 410 (four hundred and ten) nos. of empty cases of 7.62 mm ammunition,
- 15) 1 (one) white sack bag containing the above items/articles.

Accordingly, the recovered arms and ammunitions were seized at Nungjengbi Urup Hill, Urup Chingon, Imphal-East District at 6:15 pm by observing due formalities. The seized items are suspected to have been concealed by unknown miscreants probably to commit prejudicial activities.

Thereafter the seized articles are being handed over to you for taking necessary legal procedures.


